

COOKIE POLICY

INFORMATION ABOUT COOKIES

Cookies and similar technologies such as local shared objects, flash cookies, or pixels are tools used by web servers to store and retrieve information about their visitors, as well as to ensure the proper functioning of the website. These technologies allow the web server to remember certain user-related data, such as display preferences for website pages, username and password, preferred products, and more.

Cookies Subject to Regulation and Exempt Cookies

In accordance with Law 34/2002 of July 11 on Information Society Services and Electronic Commerce (LSSI), and with Regulation (EU) 2016/679 of the European Parliament and of the Council of April 27, 2016 (General Data Protection Regulation – GDPR), it is mandatory to obtain the user's express consent before using non-essential cookies on any web page.

According to the EU directive, cookies that require the user's informed consent include analytical, advertising, and affiliation cookies. Technical cookies and those necessary for the operation of the website or for the provision of services explicitly requested by the user are exempt from this requirement.

Types of Cookies

By Purpose

- **Technical and Functional Cookies**: These allow the user to navigate through a website, platform, or application and use the different options or services available.
- Analytical Cookies: These allow the party responsible for them to monitor and analyze user behavior on the websites to which they are linked. The information collected is used to measure website activity, application or platform performance, and to create user browsing profiles, aiming to improve services based on user behavior data.
- Advertising Cookies: These manage advertising spaces in the most efficient way possible, based on criteria such as the content viewed or how frequently ads are displayed.
- **Behavioral Advertising Cookies**: These collect information on users' personal preferences and choices (retargeting) to manage advertising spaces more effectively, as incorporated by the editor on a website, application, or platform.

By Ownership

- **First-Party Cookies**: Sent to the user's terminal device from a server or domain managed by the editor and from which the service requested by the user is provided.
- **Third-Party Cookies**: Sent to the user's terminal from a server or domain not managed by the editor, but by another entity that processes data obtained via cookies.

By Retention Period



- Session Cookies: Designed to collect and store data while the user accesses a web page.
- **Persistent Cookies**: Data remains stored on the device and may be accessed and processed for a period defined by the cookie owner, which can range from a few minutes to several years.

Personal Data Processing

ORBINOX VALVES INTERNATIONAL, S.L. is the Data Controller responsible for processing users' personal data and informs that these data will be processed in accordance with Regulation (EU) 2016/679 of April 27, 2016 (GDPR), and provides the following information:

- Purpose of Processing: As specified in the section on cookies used on this website.
- Legal Basis: The user's consent (Art. 6.1.a GDPR).

- **Data Sharing**: Data will not be shared with third parties, except in the case of third-party-owned cookies or if required by law.

- Right of access, rectification, data portability, and erasure, as well as the right to restrict or object to data processing.
- Right to lodge a complaint with a supervisory authority (<u>www.aepd.es</u>) if you believe the processing does not comply with applicable regulations.
